MANNA FOOD CENTER, INC DISTRIBUTES FOOD THROUGH A NETWORK OF ALMOST 60 MONTGOMERY COUNTY PUBLIC ELEMENTARY SCHOOLS. THE PROGRAM FILLS A CRITICAL GAP BY PROVIDING FOOD TO CHILDREN AND THEIR FAMILIES DURING THE SCHOOL YEAR TO ENSURE THEY HAVE NUTRITIOUS FOOD TO EAT DURING THE WEEKEND. THE PROGRAM DISTRIBUTED 486,525 POUNDS OF FOOD TO NEARLY 30,000 CHILDREN THIS PAST SCHOOL YEAR.
