MANNA FOOD CENTER, INC DISTRIBUTES FOOD THROUGH A NETWORK OF ALMOST 80 MONTGOMERY COUNTY PUBLIC ELEMENTARY SCHOOLS. THE PROGRAM FILLS A CRITICAL GAP BY PROVIDING FOOD TO CHILDREN AND THEIR FAMILIES DURING THE SCHOOL YEAR TO ENSURE THEY HAVE NUTRITIOUS FOOD TO EAT DURING THE WEEKEND. THE PROGRAM DISTRIBUTED HALF A MILLION POUNDS OF FOOD TO NEARLY 40,000 CHILDREN THIS PAST SCHOOL YEAR.
